DEFINITIVE MAP MODIFICATION ORDER 2021

This Order is made by East Sussex County Council ("the authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Secretary of State (who has directed the Authority to that effect) that the East Sussex County Council (Lewes District) Definitive Map and Statement require modification in consequence of an event specified in;

Section 53 (3)(c) (i), namely the discovery of evidence which (when considered with all other evidence available) shows that there is a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

Section 53(c) (iii), that there is no public right of way over land shown in the map and statement as a highway of any description, or that any other particulars contained in the map and statement require modification.

The Authority has consulted with every local authority whose area includes the land to which the Order relates. Accordingly, the East Sussex County Council hereby orders that:

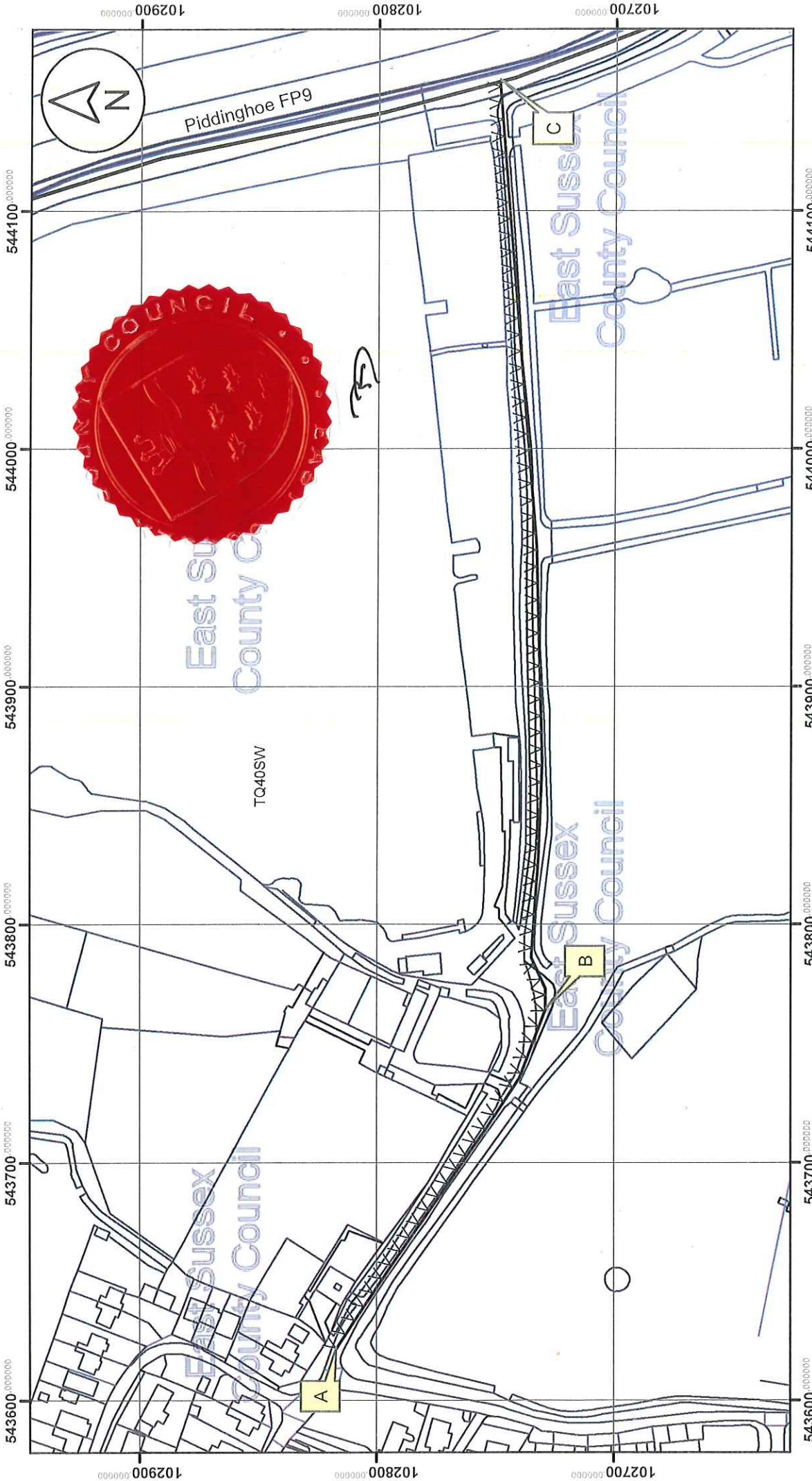
1. For the purposes of this Order the relevant date is 17th September 2021.
2. The East Sussex County Council (Lewes District) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and as shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The East Sussex (Public Restricted Byway Piddinghoe 15) Definitive Map Modification Order 2021.

Modification of the East Sussex County Council (Lewes District) Definitive Map

Description of path to be added

A route comprising a public restricted byway starting at the public highway known as The Street at TQ4362 0281 shown as point A on the plan. The route runs in a south-easterly direction for 153 metres, before turning at point B on the plan and running in an easterly direction for 403 metres until it reaches public footpath Piddinghoe 9 at TQ4415 0275 (point C on the plan).

The width of the public restricted byway between points A-B is 4 metres and between B-C 3 metres.
